I am writing to you in relation to an Appeal with regard to a quarry development at Ballinrooaun, Screen, Co. Wexford. The file reference is ABP301615-18.

We represent the Applicant (Sean and Michael Kelly) and responded to a 3<sup>rd</sup> party appeal against the Wexford County Council decision to grant permission for the development. The Applicant is quite concerned over the delay in the determination of the Appeal and the impact that it is having on their livelihood and local employment. We note the recent correspondence from ABP that a decision on the Appeal has been delayed until 7<sup>th</sup> November 2018.

The Applicant is particularly concerned that the Appeal still seems to be with the Inspector at this stage and has not been forwarded to the Board for consideration. We also understand, from the Applicant, that no one has visited the site and therefore it seems that a Site Visit has still not been carried out for the relevant Appeal which we consider will result in a significant delay on the decision and past the revised date in November, given we understand there are also significant delays at Board level.
