Waste Licence for the Operation of a Soil Recovery Facility at Midleton Quarry, within the townlands of Castleredmond, Carrigshane and Coppingerstown, Midleton, Co. Cork

Dear Sir / Madam,

In accordance with Article 9 (1) of the Waste Management (Licensing) Regulations, we hereby give written notice, on behalf of Roadstone Limited, of intention to apply to the Environmental Protection Agency (EPA) for a waste licence in respect of the operation of a soil recovery facility at Midleton Quarry. The address of the application is Fortunestown, Tallaght, Dublin 24, D24 PKK2. The facility to which the application relates is within the townlands of Castleremond, Carrigshame and Coppingerstown, Midleton, Co. Cork (National Grid Coordinates 190007E, 072481N).

The nature of the development will consist of the importation of approx. 2,520,000 tonnes of inert waste soil and stones material (LoW 17 05 04) to fill quarry voids; final restoration and landscaping to return the 15.7 Ha site to agricultural use. The proposed annual intake is 300,000 tonnes per annum. A weighbridge, wheelwash facilities, a hardstand area, storm water drainage and associated site development works will be provided. The recovery activities proposed are Class R 5 and Class R 13 as per the Fourth Schedule of the Waste Management Act 1996 as amended, as outlined below:

- The Principal activity proposed is Class R05 Recycling/reclamation of other inorganic materials, which includes soil cleaning resulting in recovery of the soil and recycling of inorganic construction materials.
- Other activity proposed includes Class R13 Storage of waste pending any of the operations numbered R 1 to R 12 (excluding temporary storage (being preliminary storage according to the definition of 'collection' in section 5(1)), pending collection, on the site where the waste is produced).

An Environmental Impact Assessment Report (EIAR) will be submitted to the Agency with the application. A copy of the application for a waste licence, the Environmental Impact Assessment Report (EIAR) and such further information relating to the application as may be furnished to the Agency in the course of the Agency's consideration of the application will, as soon as is practicable after receipt by the Agency, be available for inspection or purchase, at the headquarters of the Agency.
