

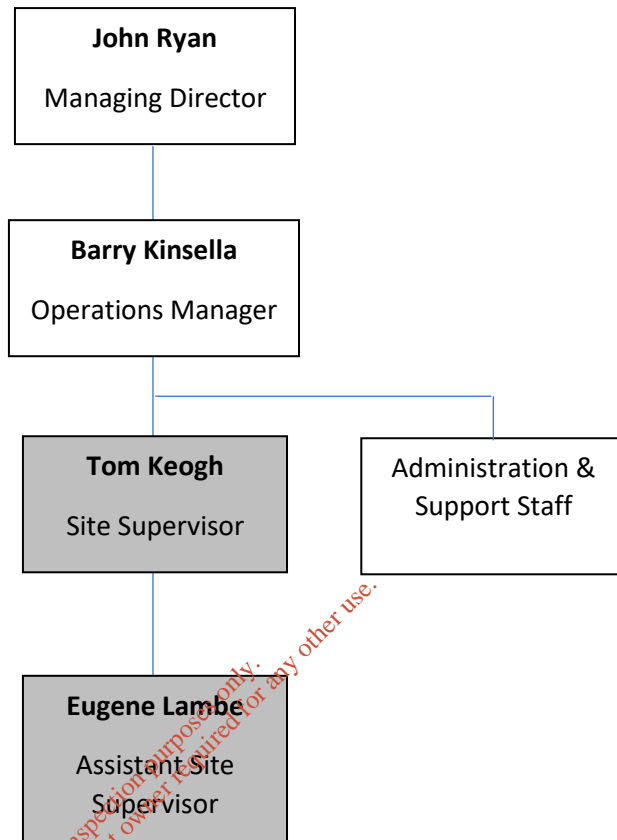

**Organisation Chart for JFK Environmental Ltd.**






