# TECHNICAL AMENDMENT A TO INDUSTRIAL EMISSIONS LICENCE

# Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0261-02 granted on the 11<sup>th</sup> February 2015 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Rye Water Valley/Carton SAC, Malahide Estuary SAC, South Dublin Bay SAC, North Dublin Bay SAC, Baldoyle Bay SAC, Rogerstown Estuary SAC, South Dublin Bay and River Tolka Estuary SPA, Malahide Estuary SPA, North Bull Island SPA and Baldoyle Bay SPA.

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. This determination is based on the fact that the recommended amendments will not result in a material change to the nature of the discharges from the agglomeration.

# Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Starrus Eco Holdings Limited, Panda Waste Management Solutions, Ballymount Road Upper, Dublin 24 for an installation located at Cappagh Road, Cappague, Finglas, Dublin 11.

This Technical amendment is limited to the following Conditions/Schedule:

## **Amendments**

### **Amended Conditions**

Amend Condition 3.24, of the licence to read as follows.

#### 3.24 Waste Acceptance Hours and Hours of Operation

- 3.24.1 Waste shall be accepted at or dispatched from the installation only between the hours of 06:00 and 23:00 Monday to Saturday inclusive, unless otherwise agreed by the Agency.
- 3.24.2 The installation may be operated twenty-four hours a day, until the 24<sup>th</sup> October 2022, subject to noise nuisance. If a further extension is not granted, from the 24<sup>th</sup> October 2022 onwards, the installation shall operate during the hours of 07:00 to 21:00 Monday to Saturday, inclusive.
- 3.24.3 The installation shall not accept/dispatch waste on Sundays or on Public Holidays without the agreement of the Agency.

Amend Condition 6.12, of the licence to read as follows.

#### 6.12 Noise

- 6.12.1 The licensee shall carry out and submit to the Agency, a noise survey of the site operations, should a noise nuisance complaint arise relating to the extended hours. Suitable mitigation measures shall be put in place to abate any noise nuisance. The survey programme shall be undertaken in accordance with the methodology specified in the 'Guidance Note for Noise: Licence Applications, Surveys and Assessments in Relation to Scheduled Activities (NG4)' as published by the Agency.
- 6.12.2 The licensee shall carry out a noise survey of the site operations annually. The survey programme shall be undertaken in accordance with the methodology specified in the 'Guidance Note for Noise: Licence Applications, Surveys and Assessments in Relation to Scheduled Activities (NG4)' as published by the Agency.



Amend Schedule C.5 Noise Monitoring, of the licence to read as follows.

#### C.5 Noise Monitoring

Period	Minimum Survey Duration
Daytime	A minimum of 3 sampling periods at each noise monitoring location. Note 2
Evening-time	A minimum of 1 sampling period at each noise monitoring location.
Night-time Note 1	A minimum of 2 sampling periods at each noise monitoring location.

Note 1: Night-time measurements should be made between 23:00hrs and 04:00hrs, Sunday to Thursday, with 23:00hrs being

Note 2: Sampling period is to be the time period T stated as per Schedule B.4 Noise Emissions, of this licence. This applies to day, evening and night time periods.

This Technical amendment shall be cited as Amendment A to the licence.
