RE: Durrus Waste Water Discharge Licence D0545-01 – Clerical Amendment Application

The Agency issued a Wastewater Discharge Licence (WWDL) for the Durrus agglomeration (D0545-01) on 09th July 2019.

Irish Water now requests a Clerical Amendment under Section 33 (1) of the Waste Water Discharge (Authorisation) Regulations 2007, as amended, to amend *Schedule A.1:* Primary Waste Water Discharge & Monitoring, and schedule A33; Storm Water Overflows of WWDL D0545-01.

A clerical error has been identified in the Durfus Waste Water Discharge Licence and Irish Water now requests the Eden codes in Schedule A.1 and Schedule A.3.1 be amended as suggested in the table below:
