RE:	Clerical Amendment to Waste Water Discharge Licence (WWDL) Register Number: D0294-02, held by Irish Water for the Agglomeration named Courtmacsherry and Timoleague.

On the 15th January 2020, Irish Water contacted the Agency in relation to the EDEN codes contained in the Courtmacsherry and Timoleague WWDL (D0294-02). Irish Water are unable to upload monitoring returns as EDEN does not recognise the codes contained in the licence.

The request relates to the correcting errors in the EDEN codes set out in the licence to those on CRM.

This memo recommends that the change may be accommodated by a Clerical Amendment, in accordance with Regulation 6(3) of the Waste Water Discharge (Authorisation) Regulations 2007 as amended.

1. Reason for Clerical Amendment

A clerical amendment is required to correct errors in the EDEN codes noted in Schedule A.1: Primary Waste Water Discharge & Monitoring; Schedule A.2: Secondary Waste Water Discharge(s) & Monitoring and Schedule A.3: Storm Water Overflows.


On investigation it has been established that the EDEN codes on CRM which are associated with the licence profile for this Agglomeration are not those contained in the licence. The primary discharge point in the Licence, Licence Code SW001, has an EDEN code TPEFF3900D0294SW001). EDEN codes were set up for the original licence application, which was submitted by Cork County Council D0294-01 (this application was subsequently withdrawn), and these are currently set up in CRM and in relevant systems used by Irish Water. EDEN codes for existing emissions points carry forward to subsequent licence versions and reflect the original applicant and therefore the appropriate code is TPEFF0500D0294SW001.

Irish Water have confirmed by licence return (LR046466) that emissions from points SW006, SW007, SW008, SW009, SW010, and SW011 have ceased. Notwithstanding this Schedule A.1: Secondary Waste Water Discharge(s) & Monitoring for these emission points has been included in the clerical amendment to facilitate the reporting of historic monitoring data by Irish Water.

2. Recommendation

I recommend that the requested changes be approved as set out in the attached recommended Clerical Amendment A.
