Article 14(2)(b)(ii) of the Waste Management (Licensing) Regulations, in respect of a licence application from Packaging Laundry Limited for a facility located at Packaging Laundry Limited, Unit C4, Oldcourt Industrial Estate, Boghall Road, Bray, Wicklow, A98P6N3

Dear Sir,

I refer to the application for a licence received by the EPA on 25 July 2019.

Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with the above mentioned legislation. You are therefore requested, in accordance with the regulations, to supply the information detailed below.

ARTICLE 12 COMPLIANCE REQUIREMENTS

- It is noted that the lease on the premises located at Unit C4, Oldcourt Industrial Estate, Boghall Road, Bray, County Wicklow which is to be used by Packaging Laundry Limited for the activities detailed in the waste licence application, expires on 27th April 2020. **Provide updated details of the site and building ownership status.**
- In the application, Packaging Laundry Limited have requested the approval of List of Waste codes (LoW): 15 01 05 Composite packaging, 15 01 01 Paper and Cardboard Packaging, 15 01 03 Wooden Packaging. **Provide details of the proposed acceptance, processing and disposal/recovery procedures for these waste types.**
- **Provide confirmation of the proposed hours of operation.** Attachment 9.4 – Environmental Management Techniques of the application notes 08:00 – 17:00 Monday to Friday. The existing waste facility permit issued by Wicklow County Council (WFP-WW-18-0043-01) authorises 08:00 – 18:00 Monday to Friday.
- **Provide a copy of the Certificate of Incorporation for Packaging Laundry Limited.** It is noted that the copy provided with the application by electronic means may not have transmitted to the EPA in its entirety.

In addition to the above, please also provide an updated non-technical summary (Application Form, and EIS where applicable) to reflect the information provided in your reply, insofar as that information impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.
