Flow then exits the lake at point B at the North-East side of the lake. Upon reviewing point no. 4 for the EPA response, regarding the surface water drains and streams with hydrological connection to Corrinshigo Lough, we've noted a difference between what was observed on site during the last visit and data available online. It would be good to schedule a site walkover to confirm the surface water bodies in the vicinity of the site, which ones are connected to Corrinshigo Lough and the flow directions. Would be that ok?
