Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0232-01 granted on 1 December 2008, and amended on 11 April 2017 (Technical Amendment A), 27 March 2018 (Technical Amendment B) and 25 April 2019 (Technical Amendment C), as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at South Dublin Bay SAC (000210), North Dublin Bay SAC (000206), Rockabill to Dalkey Island SAC (003000), Howth Head SAC (000202), Baldoyle Bay SAC (000199), South Dublin Bay and River Tolka Estuary SPA (004024), North Bull Island SPA (004006), Baldoyle Bay SPA (004016), Dalkey Islands SPA (004172) and Howth Head Coast SPA (004113).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required. The reasons for this determination are as follows:

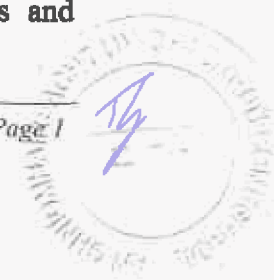
- The technical amendment, as requested, will not change the nature of the consent.
- There will be no emissions of environmental significance from the activities.
- The activities will not result in damage to, or loss of, species and habitats of these European Sites.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Dublin Waste to Energy Limited, 10 Earlsfort Terrace, Dublin 2 for an installation located at Pigeon House Road, Poolbeg, Dublin 4.

Henceforth, the licence shall be read in conjunction with a Section 76A(11) Amendment issued on 7 January 2014 and Amendment A issued on 11 April 2017, Amendment B issued on 27 March 2018 and Amendment C issued on 25 April 2019, and the amendments set out below.

- Note 3:** The individual limitation on waste streams may be varied with the agreement of the Agency subject to the overall total limit of 600,000 tonnes staying the same.
- Note 4:** Annual tonnage shall not exceed 10,000. This may be increased to a maximum of 80,000 tonnes annually subject to the submission of a detailed assessment report to the Agency and written approval of the Agency.
- Note 5:** Annual tonnage shall be limited to 10,000 per individual waste code. This may be increased with the written agreement of Agency.
- Note 6:** The acceptance of this LoW code is limited to the date specified in the Health Act 1947 (Section 31A - Temporary Restrictions) (COVID-19) Regulations 2020 (S.I. No. 121 of 2020), as amended, and in accordance with Condition 8.2.3.

This Technical Amendment shall be cited as Amendment D to the licence.
