Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, in respect of a licence review from Rilta Environmental Limited for an installation located at Rilta Environmental, Block 14A1, Grant's Road, Greenogue Business Park, Rathcoole, Dublin

Dear Mr Hussey

I refer to the application for a licence received by the EPA on 31 July 2017.

Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with the above mentioned legislation. You are therefore requested, in accordance with the regulations, to supply the information detailed below.

The following information is required in support of the application under Regulation 9 of the Regulations:

1. Details of emission point Ref Tf A1.

In correspondence dated 26/09/2018 (received by the Agency on 27/09/2018) it states that the air emission point reference Tf A1 is still in place at the installation and may be required in the future.

Please provide details of the emission point including the following, where applicable: source of the emission, the location, the grid reference (12 digit ING, 6E, 6N), vent details (diameter and height above ground (m)), volume to be emitted (average and maximum per day Nm<sup>3</sup>/day, maximum rate per hour Nm<sup>3</sup>/hr, minimum efflux velocity m.sec<sup>-1</sup>), average periods of emission (min/hr, hr/day and day/hr) chemical characteristics of the emission (prior to treatment and as discharged), the potential impact of the air emission Tf A1 on air quality and any other factors relevant to that emission.

2. Clarification of wastes for acceptance.

In correspondence dated 26/09/2018 (received by the Agency on 27/09/2018) details of proposed wastes for authorisation are provided, however it is not confirmed if all wastes currently authorised under W0185-01 are also proposed for waste acceptance as part of the application. If so please provide a description of all proposed waste activities by completing the following table (the first row is completed as an example and should be deleted to make way for real information):


