I refer to your letter dated 18.06.20 requesting additional information in respect of the above described licence application, and to subsequent correspondence extending the response period for the information sought to 5th August 2020.

We now enclose as requested the information set out below.

Article 12 Compliance Requirements 1

We now enclose a revised Drawing Ref. CP17028WL0008 (Rev P03) which includes:

- a labelled monitoring point (GW3) at the discharge of the fuel/oil interceptor
- coordinates of this monitoring point (Irish grid reference, 6-digit easting and 6-digit northing) •

We also enclose a revised Drawing showing the Monitoring Locations Drawing Ref. CP17028WL0017 (Rev P02).

2 **Article 13 Compliance Requirements**

For compliance with Article 13 the following information is now provided. These were inadvertently omitted from the documents provided with the initial application:

- A non-technical summary of the EIAR of the information referred to in points (a) to (d) of Article 5(1) of the EU EIA Directive.
- A reference list of sources used for descriptions and assessments included in the EIAR.

3 **Appropriate Assessment**

Further to the screening for appropriate assessment by the EPA on 11.06.20 which determined that an Appropriate Assessment of the proposed activity is required, we hereby submit as requests a Natura Impact Statement in accordance with the requirements of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended.

4 Other Revised Documentation

Your letter dated 18.06.20 also sought an updated non-technical summary (and Application Form, and EIAR where applicable) to reflect the information provided in our reply to the above-mentioned items, insofar as that information impinges on the non-technical summary.
