TRANSFER OF AN INDUSTRIAL EMISSIONS LICENCE

Decision of the Agency, under Section 94 of the Environmental Protection Agency Act 1992 as amended

The Agency, in exercise of the powers conferred on it by the Environmental Protection Agency Act 1992, as amended, for the reasons hereinafter set out, hereby transfers licence Register No W0238-01 and any associated amendments from Dublin City Council, Civic Offices, Wood Quay, Dublin 8 to Starrus Eco Holdings Limited, Ballymount Road Upper, Dublin 23, CRO No. 527552.

Licence Register No: W0238-01 licenses the carrying on of the activities set out below at, Merrywell Industrial Estate, Ballymount Road Lower, Ballymount, Dublin 12, subject to twelve conditions, as set out in the Licence.

In accordance with Section 94 of the Act, Starrus Eco Holdings Limited, is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, that may arise.

REASONS FOR THE DECISION

Pursuant to Section 94(5)(a) of the Act, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited is entitled to be regarded as a fit and proper person to be granted a like Industrial Emissions licence. Pursuant to Section 94(5)(b) of the Act, the Agency is satisfied, on the basis of the information available, that Starrus Eco Holdings Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the Programme Officer's report.
