TECHNICAL AMENDMENT A

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. **W0055-02 granted on 24 January 2006, (and amended on 31 December 2013)** as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at **Glenasmole Valley SAC (001209), Wicklow Mountains SAC (002122), Rye Water Valley/Cartron SAC (001398), South Dublin Bay and River Tolka Estuary SPA (004024), South Dublin Bay SAC (000210), and Wicklow Mountains SPA (004040).**

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required.

It has been determined that this installation is not likely to have a significant effect on the European Sites as the change does not substantially change the current nature of operations and emissions at the installation.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to **SRCL Limited, 430 Western Industrial Estate, Naas Road, Dublin 12, CRO Number 258299**, for an installation located at **430 Beech Road, Western Industrial Estate, Naas Road, Dublin 12, Dublin.**

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on the **31st December 2013** and the amendments set out below.

This Technical Amendment is limited to the following Condition:

Amended Conditions

Amend Condition 1.4 of the existing licence to read as follows:

- 1.4** For the purposes of this licence, the **installation authorised by this licence** is the area of land outlined in **green in section ‘6. Site Plan’, on page 4 of the Site Closure Plan (attachment: ‘SRCL_BR_SCP_420_’)** received **25-08-2020**. Any reference in this licence to **“installation”** shall mean the area thus outlined in **green**.

This Technical Amendment shall be cited as Amendment A to the licence.
