Notice for the purposes of Section 87(1)(b) of the EPA Act 1992 as amended – Review by the Agency of a licence located at Anglo Beef Processors Ireland t/a ABP Proteins Waterford, Christendom, Ferrybank, County Waterford.

Dear Mr. Durkan,

I am to advise, in accordance with Section 87(1)(b) of the EPA Act, 1992, as amended, that the Agency intends initiating a review of your existing IE Licence, Register Number: P0040-02 for an installation located at Christendom, Ferrybank, County Waterford.

For the purposes of the review, the reference number in the Register of Licences is **P0040-03**.

The review is being initiated, in accordance with Section 90 (4)(a)(i) of the EPA Act, 1992, as amended, due to material changes in the nature and extent of emissions at the installation.

The Agency shall publish a notice of such intention in the Irish Independent newspaper on 08th of December 2020.

In accordance with Section 90 (7) of the EPA Act, 1992, as amended, you are requested to furnish the attached form within 8 weeks to include the following:

- Impact assessment reports and/or dispersion models (air, noise, odour, surface water) (Section D.1 and attachment 7.1).
- Details on emissions points and monitoring points to surface water (incl. storm water) and air section (incl. odour and noise (Section B.5)).
- Site boundary map.
- Map of treated process effluent and surface water/storm water discharges drainage system.

- Detailed site map indicating location of main air emission points and main treated process effluent discharge/stormwater discharge points.
- Details on characteristics of treated effluent (Section D and attachment 7.1).
- Monitoring results to air (incl. noise and odour) and to surface water (including storm water) (Section D.1).
- Submission of Baseline Report (Section D.2).

Relevant sections of the review form are available <u>here</u> for download for uploading to EDEN if required.

Please upload all relevant information via EDEN within eight weeks of receiving this notice.

In accordance with Regulation 12(3) of the Environmental Protection Agency (Industrial Emissions) (Licensing) Regulations 2013 you are entitled, but not required, to make a submission to the Agency within four weeks of the date of this notice. A 'Regulation 12(3) Submission' can be submitted to the Agency via EDEN.

It should be noted that the eight-week period within which the Agency is to decide the proposed determination will commence on the day on which this notice has been complied with.

It should be noted that where you fail or refuse to comply with the above requirements of the Agency within the specified timeframe, the Agency may proceed to determine the review without the requested information.
