Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0217-02 granted on 8 February 2019 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Act 1996 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Killarney National Park, Macgillycuddy's Reeks and Caragh River Catchment SAC (000365), Castlemaine Harbour SAC (000343), Sheheree (Ardagh) Bog SAC (000382), Killarney National Park SPA (004038), Castlemaine Harbour SPA (004029).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

- Only uncontaminated storm water is passed through the reed beds discharging to a percolation area, therefore, the proposed amendment will not result in a significant effect on species and habitats of the European Sites.
- The recommended technical amendment, for the inclusion of the reed beds in the storm water treatment system, will not change the nature of the activity.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(b) of the Waste Management Act 1996, as amended, the Agency amends Licence Reg. No. W0217-02, granted to Killarney Waste Disposal Unlimited Company, for a facility located at Aughacurreen, Killarney, County Kerry.

Henceforth, the licence shall be read in conjunction with the amendments set out below.

This Technical amendment is limited to the following Conditions:

Amendments

Amended Condition

Amend Condition 6.15.5, of the existing licence to read as follows:

6.15.5 Storm water from paved areas shall be directed to the percolation area after treatment in a silt trap, oil separator and reed beds, as labelled in Dwg No. 02 entitled "DRAINAGE" of the application.

This Technical Amendment shall be cited as Amendment A (in pursuance of Section 42B(1) of the Waste Management Act 1996 as amended) to Waste Licence Register No. W0217-02.
