Thank you for your email. Unfortunately, most of the functions in Eden for historic landfills are not working at present.

In general, Historic Landfill applications have to be submitted to the Agency via file transfer by email and any correspondence from the EPA is sent by email or post, outside Eden.

The extension of the statutory periods as provided for in Regulation 7(5) of the Waste Management (Certification of Historic Unlicensed Waste Disposal and Recovery Activity) Regulations 2008 are notifications sent to you via Eden. You should be able to see the notification on Eden if you could try again please. However, please find attached the latest extension notification that was sent via Eden for your ease of reference.
