Any application for Judicial Review or any other legal proceedings which question the validity of the decision of the Agency must, in accordance with Section 87(10) of the Act of 1992, be instituted within the period of 8 weeks beginning on the date of the giving of the decision, and, a person shall not question the validity of the decision of the Agency other than by way of an application for Judicial Review under Order 84 of the rules of the Superior Courts (S.I. No. 15 of 1986).
