1. Provide evidence that a newspaper notice was published in according with Regulation 4(1) of the Industrial Licensing Regulations (5, 1, no 137 of 2013).

Please find a copy of the newspaper enclosed.

2. Provide details on the impact of emissions from the facility on nearby European sites. It may be appropriate to use SCAIL (or alternative) to support your assessment. This information should be included in an updated NIS. Raw input data that is included in the model and any assumptions made should be submitted to the Agency in your response.

Please refer to NIS and ammonia impact assessment contained in the E.I.A.R. completed in respect of this development.

3. A BAT Assessment was submitted in Section 4.7 of the application form. Please review and if appropriate the table entries in relation to BAT 16, 30 and 32.

Response to BAT 16 is appropriate as there are no ancillary manure stores on the farm.

Response to BAT 30 is appropriate as no new structures are proposed and nutritional techniques are proposed to minimise emissions. Notwithstanding same pleas refer to Additional Measures included in EIAR Re: BAT Compliance.

Response to BAT 32 (or lack thereof in this instance), is appropriate as same relates to broilers, not pigs.

6. Section 9.1 of the Application form it is stated that there is no emergency response procedure for the facility. Provide details on the measures in place to deal with event of a spillage of slurry on site. Provide details of any alternative arrangements in place for acceptance of your slurry off -site.

Off-site manure storage facilities are available as referred to in the E.I.A.R.

Provide clarification on slurry storage capacity at the installation. The documentation states that the exiting storage is 4,586 m³ and the proposed storage is 5,752 m³. Is this additional to or inclusive of the existing storage. Provide information on the current levels of slurry generated per year.

Please refer to EIAR – Appendix N0. 1 EIS (Appendix 2 thereof) Total Storage capacity on the farm is 10,338m3. Estimated slurry production = 8,112 m3.

8. The proposal is to use approx.. 7,500 m³ of groundwater per annum. There is no evidence in the EIS or the application of an assessment of the impacts of using this volume of water or other users in the area. What contingency plans are in place if the yield of this well is reduced during extended periods of dry weather?
