Re: Response to Request for Additional Information dated 08th April 2021 and 17 December 2019 in respect of an Application for a Review of Industrial Emissions Licence Register No. W0232-02 (the "Licence Review Application") (the "RFI")

Dear Sir or Madam

We refer to the Licence Review Application to increase the permitted maximum annual quantity of waste to be accepted at the Dublin Waste to Energy (\*\*DWtE\*\*) facility from 600,000 tonnes per annum to 690,000 tonnes per annum (the "Activity").

We also refer to the RFI requesting "evidence of planning permission for the additional 90,000 tonnes or in its place confirmation from An Bord Plannial that additional planning permission is not required (Regulation (9)(2)(e))".

We wish to inform the Agency that on 25th March 2021, DWtE submitted an application for planning permission to An Bord Pleanála in respect of the Activity (Planning Reference PL29S.309812) (the "Planning Application").
