Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0045-01 granted on 18 December 2000, (and amended on 26 June 2016) as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Act 1996, as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Glenasmole Valley SAC (001209), South Dublin Bay SAC (000210), Wicklow Mountains SAC (002122), Rye Water Valley/Carton SAC (001398), North Dublin Bay SAC (000206), Knocksink Wood SAC (000725), South Dublin Bay and River Tolka Estuary SPA (004024), Wicklow Mountains SPA (004040) and North Bull Island SPA (004006).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

The reasons for which the Agency determined that an Appropriate Assessment of the activities is not required are as follows:

- The proposed technical amendment, to accept non-hazardous LoW code 18 01 01 for storage, will not change the nature of the consent.
- There will be no emissions of environmental significance from the activities.
- The activities will not result in damage to, or loss of, species and habitats of these European Sites.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Act 1996, as amended, the Agency amends Licence Reg. No. W0045-01, granted to Key Waste Management Limited, Greenview, Greenhills Road, Walkinstown, Dublin 12, CRO Number 400662, for a facility located at Greenview, Greenhills Road, Walkinstown, Dublin 12.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 26 June 2016, and the amendments set out below.

Part I: Activities licenced

Amend Class 13 of licenced waste recovery activities in Part I: Activities licenced, of the existing licence as follows:

Class 13: Storage of waste intended for submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where such waste is produced.

This activity is limited to the storage of non-hazardous commercial, construction / demolition, **health care** and industrial waste received at the facility, prior to recovery at an alternative appropriate facility.

Amend Class 13 of licenced waste disposal activities in Part I: Activities licenced, of the existing licence as follows:

Class 13: Storage prior to submission to any activity referred to in a preceding paragraph of this Schedule, other than temporary storage, pending collection, on the premises where the waste concerned is produced.

This activity is limited to the temporary storage of non-hazardous commercial, construction / demolition, **health care** and industrial waste at the facility for disposal off-site.

Note 1: These figures may change subject to the prior agreement of the Agency; however, the total waste to be accepted at the facility shall not exceed 300,000 tonnes per annum.

Note 2: The acceptance of non-hazardous health care waste is limited to LoW 18 01 01, subject to Condition 5.3.1. and the end date specified in the Health Act 1947 (Section 31A -Temporary Restrictions) (COVID-19) (No. 10) Regulations 2020 ("SI 701/2020"), as amended, or such end date in relation to the period during which the Covid-19 temporary restrictions shall apply as may be set out in any Statutory Instrument enacted in place of S.I. 701/2020.

This Technical amendment shall be cited as Amendment B, (in pursuance of Section 42B(1) of the Waste Management Act 1996 as amended) to Waste Licence Register No. W0045-01.
