Dear Sirs,

Key Waste Management Ltd is an established waste management company operating from a licensed segregation / transfer station at Greenhills, Dublin 12. Waste collection / disposal services are provided to domestic, commercial and healthcare locations.

An issue has arisen in recent weeks in our ability to service our existing clients in the healthcare sector. Due to the ongoing Covid 19 pandemic, clinical waste arising at healthcare locations has dramatically increased.

KeyWaste collects this waste from clients an transports it directly to a dedicated licensed treatment and disposal facility operated by SRCL Ltd at Beech Road, Naas Road Industrial Estate, Dublin 12 (Licence W0055-02).

This is the only facility treating clinical waste in the Republic of Ireland .Because of the larger volumes now arising in the healthcare sector, the SRCL facility is having difficulties coping with the waste volumes, which is causing usual scheduled delivery vehicles to be detained outside the facility for up to seven hours per day. This is causing disruption to customer services and additional costs to the company. The collection, delivery of clinical waste, normally can only be carried out during standard daytime business hours.

Therefore, our request to the agency, is for a temporary derogation to the KeyWaste licence to allow for the temporary storage of clinical waste, stored in UN approved locked containers, which will be held in a secure area at the KeyWaste transfer station site.

The proposed duration of storage we estimate will not exceed 48 hours.

The volumes we expect are approximately 80 bins per day .Details of each bin, will be supported by relevant WTF documentation.
