# TECHNICAL AMENDMENT B TO INDUSTRIAL EMISSIONS LICENCE

## Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0257 granted on the 30<sup>th</sup> January 2014 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Cork Harbour SPA (004030) and Great Island Channel SAC (001058).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. This determination in based on the fact that the proposed amendments will not result in an increase in emissions from the activity.

### Technical Amendment

In pursuance of the powers conferred on it by Section 96(1) (c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Country Clean Recycling Limited, for an installation located at Churchfield Industrial Estate, John F. Connolly Road, County Cork.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on 11<sup>th</sup> November 2015 and Amendment A issued on 29<sup>th</sup> June 2016.

This Technical Amendment is limited to the following Conditions:

## **Amendments**

#### **New Conditions or Amended Conditions**

Amend Condition 1.3 of the licence to read as follows.

#### Condition

1.3

For the purposes of this licence the facility is the area of land outlined in red on Map titled "Proposed EPA Licenced Boundary" submitted to the Agency, dated 07/08/2020. Any reference in this licence to the 'installation' shall mean the area thus outlined in red. The licensed activities shall be carried on only within the area.

Amend Condition 3.25 of the licence to read as follows.

- 3.25 Timber Shredding and Storage
- The timber shredder and timber shredding area shall be enclosed to contain and restrict dust and noise emissions.
- 3.25.2 Stockpiles of processed timber and shredded material shall be contained within designated areas of the waste transfer station building to minimise dust generation.
