Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Register number **W0205-01** granted on the **28**th **May 2007**, (**16**th **December 2015 and 29**th **June 2016**) as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Rye Water Valley/Carton SAC, Glenasmole Valley SAC, Wicklow Mountains SAC, South Dublin Bay SAC, North Dublin Bay SAC, South Dublin Bay and River Tolka Estuary SPA, Wicklow Mountains SPA and North Bull Island SPA.

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. This determination is based on the fact that the proposed amendments will not result in a material change to the nature of the discharges from the installation.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Green Circular Economy Unlimited Company, Crag Avenue, Clondalkin Industrial Estate, Clondalkin, Dublin 22 for an installation located at Crag Avenue, Clondalkin Industrial Estate, Clondalkin, Dublin 22.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on 16th December 2015 and Amendment A issued on 29th June 2016, and the amendments set out below.

This technical amendment is limited to the following Schedule:
