EDEN

Licence Contacts

Following registration on EDEN you are required to submit a Licensee Return (Site Updates/Notifications – Contact) supplying the name and contact details (address, email address and phone number(s) etc.) for the Primary contact and Secondary contact for your facility in relation to enforcement of your license. Additional (Tertiary contacts) may also be included.

The primary, secondary and tertiary contacts will be the persons notified of any correspondence/notifications from the EPA.

Incident Notification

The management and communication of any incidents to the EPA shall be in accordance with the EPA's Guidance; "Guidance on the Notification Management and Communication of Environmental Incidents" which can be accessed at: <http://www.epa.ie/enforcement/how/incidents%20at%20licensed%20facilities/>
All incidents must now be reported via EDEN.
