

Notice for Public Consultation on Appropriate Assessment

under Regulation 42 of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended

The EPA on 15/12/2021 issued an Appropriate Assessment Screening Determination to Louth County Council for a facility located Collon Road, Mell, Drogheda, Louth, A92 N126 regarding an waste licence review application, Register Number W0033-02.

Classes and Nature of Activity in accordance with the Waste Management Act 1996 as amended

Louth County Council was granted a waste licence; Reg. No. W0033-01 on 31/12/1999 for the closure, capping and restoration of the landfill facility. This is a closed and restored landfill with an operational civic amenity waste facility. The application is to change the boundary of the closed landfill to undertake capping and provide appropriate monitoring of an area where historically waste was landfilled by Drogheda Borough Council.

The EPA has carried out an Appropriate Assessment Screening and has determined that an

Appropriate Assessment <u>is required</u> for the activity. The applicant will be requested to submit a Natura Impact Statement.

- Additional information submitted on the Natura Impact Statement

Information on making submissions or observations and on the public participation process is available on the Agency's website.

The EPA shall publish its proposed decision (grant/refusal) on its website, and before making a final decision, the EPA shall consider any objections / submissions on objections. The final decision will also be published on the website.
