RE: WASTE LICENCE REVIEW APPLICATION TO THE ENVIRONMENTAL PROTECTION AGENCY BY ROADSTONE LIMITED IN RESPECT OF SOIL AND STONE WASTE RECOVERY ACTIVITY AT HUNTSTOWN SOUTH QUARRY, NORTH ROAD, FINGLAS, DUBLIN 11

We write on behalf of our Client, Roadstone Limited to formally advise that it has submitted a waste licence review application to the Environmental Protection Agency (EPA) in respect of soil and stone waste recovery activity at Huntstown South Quarry and Huntstown Quarry Complex, in Huntstown, Kilshane, Johnstown, Grange and Cappogue townlands, North Road, Finglas, Dublin 11 (National Grid Reference 3709E 2419N).

The waste licence review application provides for

- (i) importation of soil and stone waste to the western side of Huntstown South Quarry at a maximum rate of 750,000 tonnes per annum (as currently permitted by Planning Ref. FW12A/0012);
- (ii) extension of the licensed site boundary to incorporate the proposed waste recovery area on the western side of the South Quarry and the haul roads leading to / from it;
- (iii) an increase in the total permitted (lifetime) soil and stone waste intake to the (extended) waste facility to 18.76 million tonnes;
- (iv) continued use of pre-existing site infrastructure to support these activities; and
- (v) re-routing of internal traffic flows to and from the backfilling / recovery area at the South Quarry across pre-existing haul roads within the quarry complex.

The principal activity is Class R5 as per the Fourth Schedule of the Waste Management Act 1996, as amended (recycling or reclamation of other inorganic materials, which includes soil cleaning resulting in the recovery of the soil and recycling of inorganic construction materials).

Other activities include Class R3 of the Fourth Schedule (recycling or reclamation of organic substances which are not used as solvents) and Class R13 of the Fourth Schedule (storage of waste pending any of the operations numbered R1 to R12 (excluding temporary storage, pending collection, on the site where the waste is produced)).

An Environmental Impact Assessment Report (EIAR) will be submitted to the Agency in support of the waste licence review application, together with a copy of the Environmental Impact Statement (EIS) previously submitted in respect of the current quarry permission which includes provision for quarry restoration by backfilling / soil waste recovery (Ref. FW12A/0022 and ABP PL06f.241693).

A copy of

- (i) the Waste Licence Review Application,
- (ii) the Environmental Impact Assessment Report and
- (iii) further information relating to the application that may be furnished to the Agency in the course of its consideration of the licence application

will, as soon as practicable after receipt by the Agency, be available for inspection or purchase at the headquarters of the Agency.

This letter constitutes formal written notice of the Waste Licence Review Application as required by Section 9(1) of the Waste Management (Licensing) Regulations 2004 (S.I. No. 395 of 2004).
