Further Notice under the EPA (Industrial Emissions) (Licensing) Regulations 2013, in respect of a licence application from William Connolly & Sons Unlimited Company for an installation located at William Connolly & Sons Unlimited Company, Grange Lower, Goresbridge, Kilkenny, R95 EKH4

Dear Sir or Madam,

I refer to the EPA's notices of 20/11/2018, 18/12/2019, 07/07/2020, 13/05/2021 and 16/12/2021 requesting information in respect of your licence application and to your responses dated 30/10/2019, 15/05/2020, 03/06/2021, 12/07/2021, 30/11/2021, 19/12/2021 and 07/01/2022.

You are advised that there remains outstanding information, as required under the EPA (Industrial Emissions) (Licensing) Regulations 2013, as amended. You are therefore required to submit the outstanding information detailed below:

- 1. Confirm the main Class of Activity under the First Schedule of the EPA Act 1992, as amended, that William Connolly & Sons Unlimited Company are applying for.
- 2. A revised Air Dispersion Model demonstrating that all relevant emissions to air from the installation will comply with relevant Air Quality Standards.
- 3. A revised Attachment 7.4.1 Emissions to Air Main and Fugitive.
- 4. A revised noise impact assessment to include impacts at sensitive receptors including the neighbouring SAC.
- 5. An updated Attachment 4.6.2 Raw Materials, Intermediates and Products.
- 6. An updated Attachment 8.1 Waste Generated.
- 7. An assessment of the integrity of both the existing Integrated Constructed Wetland (ICW) and the ICW Extension.
- 8. An updated Non-Technical Summary to reflect the information provided in your reply, insofar as that information impinges on the non-technical summary.

With a view to advancing this application for determination, the above mentioned information must be submitted to the EPA by 31/03/2022.

Please note that no further time extension for the submission of this outstanding information shall be provided.

It should be noted that failure to comply with this request may result in the EPA progressing its action under Regulation 19 of the EPA (Industrial Emissions)(Licensing) Regulation 2013 which pertains to Withdrawal or Abandonment of application for a licence. Have regard in particular to:

(3) Where a notice has been given under paragraph (2), the Agency may, at any time after the expiration of the period specified in the notice, and after considering the submission (if any) made to the Agency pursuant to the notice, declare that the application to which the notice relates shall be regarded as having been abandoned.
