Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, in respect of a licence review from ERAS ECO Limited for an installation located at ERAS ECO Ltd, Foxhole, Youghal, Cork, P36F903

Dear Sir or Madam,

I refer to the application for a licence received by the EPA on 18th January 2022.

Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with the above mentioned legislation. You are therefore requested, in accordance with the regulations, to supply the information detailed below.

The Agency notes the licence application documentation is seeking a change in the waste acceptance tonnage to allow the acceptance and digestion of 65,000 tonnes/per year of organic waste (Ref. Attachment 1.1 Reason for Review). The current licence W0211-02, permits the acceptance of 40,000 tonnes per annum of commercial, industrial and household waste, 20,000 tonnes per annum of non-hazardous sludge, and 5,000 tonnes per annum of leachate from landfills, and An Bord Pleanála approved these capacity limits as proposed in the W0211-02 licence application.

Please submit to the Agency evidence of planning permission to allow the acceptance and digestion of 65,000 tonnes/per year of organic waste, or in its place confirmation from An Bord Pleanála that additional planning permission is not required. [Regulation (9)(2)(e)]

In addition to the above, please also provide an updated non-technical summary (Application Form, and EIAR where applicable) to reflect the information provided in your reply, insofar as that information impinges on the non-technical summary.

The requested information should be submitted to the Agency within three months of the date of this notice, in order to allow the Agency to process and determine your application.


