Observations: the planning application is for the construction of additional covered accommodation and a geo-membrane lined covered slurry tank. The Dept of Agriculture has newly issued specifications for the construction of the geo-membrane lined tanks (S.126, June 2006) and it would be very important that such specifications would be adhered to. The application itself is located within an existing pig farm complex. The construction of the various facilities on the farm could be catered for by the insertion of a condition such as:

The construction of all facilities including pig accommodation and sturry storage facilities to be line with current relevant. Department of Agriculture Specifications (such as \$126 for geo-membrane-lined tanks).

Reason: to ensure that all works are carried out in according with current good practice and standards.

One of the deficiencies in the information provided, in this case is the lack of Nutrient Management Plan (NMP). This would involve the provision of maps and of a land bank sufficient in area and nutrient deficiencies to eater for the waste produced which has been calculated at 7950m3 per annum (EIS. P.8). It is likely that this information will have to be provided as part of the IPPC application to the EPA. The Planning Authority cannot place environmental conditions on activities subject to an IPC licence. However it would be best that that information be provided to the Planning authority ion due course.

Planning History: 06/3081 granted in March 207 for Loose Dry Sow House.

Recommendations; development to proceed subject to the condition outlines above and the following:

1 That following granting of the IPPC licence by eth EPA that he documentation associated with

Reason: in the interests of clarification of the destination of all nutrients that are exported from the site.

2 That all on farm activities be carried in accordance with contents of the IPPC licence.

Reason: to minimise the chances of environmental pollution.
