I am writing to inform you that notice is hereby given in accordance with the E.P.A. Act 1992 as amended, that Amazon Data Services Ireland Limited, One Burlington Plaza, Burlington Road, Dublin 4 (Company Registration no. 390566), intends to apply to the Environmental Protection Agency (E.P.A.) for an industrial emissions licence for the installation located at Grange Castle Business Park South, Baldonnell Road, Baldonnell, Dublin 22, National Grid Reference E 302918, N 230689.

In accordance with the First Schedule to the E.P.A. Act 1992 as amended the class and nature of the Industrial Emissions Directive activities is:

The EIAR submitted to the Agency in accordance with section 83(2A)(d) of the Act of 1992, any information provided to the Agency under paragraph (e) or (f)(ii)(II) of section 83(2A) of the Act of 1992, any opinion issued by the Agency under section 83(2A)(de) of the Act of 1992 on the scope of the environmental impact assessment report, and any further information, including reports and advice, relating to the environmental impact assessment as may be furnished to the Agency in the course of the Agency's consideration of the application, shall each be made available on the Agency's website and at the headquarters of the Agency.


Submissions may be made in writing to the Agency in relation to the likely effects on the environment of the proposed activity within the period specified by the Agency on its website under Regulation 4(2)(c). In accordance with section 87(2) of the Act of 1992, a proposed determination shall be published by the Agency on its website.
