## ***Reasons for the Decision***

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0304-01 granted on 15 October 2020 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Act 1996 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Rockabill to Dalkey Island SAC (003000), Dalkey Islands SPA (004172), Bray Head SAC (000714).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required.

This determination is based on the following reasons:

- the installation is not within any European Site;
- the discharge to sewer from the facility is to the Shanganagh WWTP, which is subject to an EPA Waste Water Discharge Licence (Reg. No. D0038-02); and
- given the distance to the European Sites, the nature of the receiving environment, and capacity on the Shanganagh sewer network, the proposed changes will not have an impact on the European Sites listed above.

## ***Technical Amendment***

In pursuance of the powers conferred on it by Section 42B(1)(c) of the Waste Management Act 1996 as amended, the Agency amends the licence, granted to Packaging Laundry Limited, for a facility located at Unit C4, Oldcourt Industrial Estate, Boghall Road, Bray, County Wicklow.

Henceforth, the licence shall be read in conjunction with the amendments set out below.

This Technical Amendment is limited to the following Schedule:


