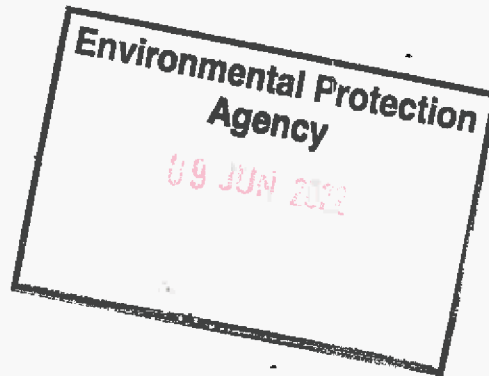

### Monitoring Fees

In relation to the monitoring fee (€1,083.00) for **Cootehill H0020-01** – as per Condition 2.4 of the COA issued by the Agency in December 2020, I am requesting that this fee be waived going forward and that fee(s) paid by Cavan County Council to date be refunded on the basis that this site contains no waste since it was originally fully remediated prior to submission of COA application.

### Application Fees

In relation to the application fees paid to the Agency in respect of the three above sites (€ 5,000.00 per site) at the time of application submissions in 2013 & 2014 -- I note under Regulation 7(3) of SI No. 524 of 2008 that the Agency may "refund or waive all or part of the fee payable" "where it is satisfied that the payment in full of the fee would not be justified or reasonable having regard to the limited scale or nature of the landfill activity concerned".

Therefore, with regard to **Cootehill H0020-01** – I am requesting a full refund of the application fee paid (€5,000) originally as this site had all waste removed at the time of remediation.




In relation to **Kingscourt (H0016-01) & Mullagh (H0022-01)** sites -- I am requesting a full refund of the application fees paid (€10,000) due to ;

- 
- The significant amount of expenditure involved in the remediation of both sites
  - Costs incurred to date by Cavan County Council in relation to installation of Environmental Monitoring infrastructure and environmental monitoring costs incurred to date
  - Reduction in Risk Rating as a result of substantial and successful remediation works.
