## **AA Screening Determination:**

That the activity is not directly connected with or necessary to the management of any European site and that it cannot be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European site and accordingly determined that an Appropriate Assessment of the activity is required, and for this reason determined to require the applicant to submit a Natura Impact Statement.

This determination has been made in light of the following reasons:

- Due to the nature and scale of the activity (operation of 27 diesel powered back-up generators and 2 diesel powered fire sprinkler pumps) and the proximity to European Sites.
   The closest European Site is the River Boyne and River Blackwater SAC approximately 1km to the north. Air emissions of NO<sub>x</sub> from the diesel-powered equipment has the potential to impact on qualifying interests within this European site.
- There is a hydrological connection between the installation and the River Boyne and River Blackwater SAC via the surface water drainage system. There are proposed emissions to surface water of residual cooling water associated with the evaporative cooling process in the Air Handling Units. Potential effects of these proposed emissions on the receiving European site and its qualifying interests cannot be ruled out.
