AA Screening Determination:

That the activity is not directly connected with or necessary to the management of any European site and that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European site and accordingly determined that an Appropriate Assessment of the activity was not required.

This determination has been made in light of the following reasons:

1. The Sullane River (IE_SW_19S020200), the receiving water for waste water discharges from the agglomeration, is currently assigned 'High' water quality status under the 2013-2018 Water Framework Directive (WFD) reporting period.

- 2. The proposed treated discharges, which are of a small scale due to the Ballyvourney/Ballymackeery agglomeration's low population equivalent (p.e.) (projected 10-year load of 968 p.e.), will also result in a positive impact on the receiving water quality due to the removal of untreated wastewater discharges.
- 3. The qualifying interests of St Gobnet's Wood SAC, Mullaghanish to Musheramore Mountains SPA, the Mullaghanish Bog SAC, the Blackwater River SAC and Killarney National Park, Maggillycuddy's Reeks and Caragh River Catchment SAC have no hydrological or hydrogeological connection with the proposed discharges.
- 4. The Gearagh SAC and the Gearagh SPA are located approximately 10km upstream of the proposed discharges. The proposed discharges will not impact on the qualifying interests of these European sites due to the lack of hydrological and hydrogeological connection and due to the distance between the discharges and the sites.
- 5. Cork Harbour SPA and Great Island Channel SAC are hydrologically connected to the proposed discharges but the proposed discharges are considered to have no impact on the qualifying interests of the European sites due to the large distance (approximately 50km) between the discharges and the sites.
