TECHNICAL AMENDMENT A
TO
WASTE LICENCE

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0269-01 granted on 06 April 2011 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Act 1996, as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Ballyman Glen SAC (000713), Knocksink Wood SAC (000725), Bray Head SAC (000714), Wicklow Mountains SAC (002122).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required.

The reasons for this determination are:

- The installation is not located within any European site, and
- The proposed site boundary reduction does not substantially change the nature or extent of the operations and emissions at the facility from what was considered when licence Reg. W0269-01 was granted.

Technical Amendment

In pursuance of the powers conferred on it by Section 42B(c) of the Waste Management Act 1996 as amended, the Agency amends the licence, granted to Roadstone Limited for a facility located at Fassaroe Waste Recovery Facility, Fassaroe Avenue, Fassaroe, Bray, County Wicklow.

Henceforth, the licence shall be read in conjunction with the amendments set out below.

This Technical Amendment is limited to the following Condition:

Amendments

Amended Condition

Amend Condition 1.3 of the existing licence to read as follows:

Condition 1.3

For the purposes of this licence, the facility authorised by this licence is the area of land outlined in black on “Figure No. 3, Site Layout Map”, received by the Agency on 31/08/2022. Any reference in this licence to “facility” shall mean the area thus outlined in black. The licensed activities shall be carried on only within that area outlined.

This Technical Amendment shall be cited as Amendment A to the licence.
