**Re: Notice in accordance with Regulation 18(3)(b) of the European Union (Waste Water Discharge) Regulations 2007 to 2020**

Dear Sir,

We refer to your application for a waste water discharge licence relating to agglomeration named Grenagh, Reg. No. D0544-02.

Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Regulation 16 of the European Union (Waste Water Discharge) Regulations 2007 to 2020.

You are therefore required, in accordance with Regulation 18(3)(b) of the Regulations, to take steps to supply the information detailed below:

**REGULATION 16 COMPLIANCE REQUIREMENTS**

1. Provide a copy of the planning documentation as per Regulation 16(3A).
2. Having regard to the 95<sup>th</sup>ile flow estimate of 0.045m<sup>3</sup>/s for the receiving water as provided by the EPA in August 2022, update the impact assessment of waste water discharges on the receiving water and your application as appropriate or justify your assessment.
3. Confirm whether Figure 1 in the Attachment D.2.6 Hydrological Estimation Report is correctly described as "Glaslough WWTP Outfall, River Flow Measuring Location and Contributing Catchment Areas".
4. Give timeframes for the provision of phosphorus removal facilities and composite sampling and flow monitoring at the waste water treatment plant.
5. Provide the monitoring data for ammonia and orthophosphate as referenced in section B.2.2 Table 7 of the application.

Your reply to this notice should include a revised non-technical summary which reflects the information you supply in compliance with the notice, insofar as that information

impinges on the non-technical summary.

In the case where any drawings already submitted are subject to revision consequent on this request, a revised drawing should be prepared in each case. It is not sufficient to annotate the original drawing with a textual correction. Where such revised drawings are submitted, provide a list of drawing titles, drawing numbers and revision status, which correlates the revised drawings with the superseded versions.

Please supply the information by 31 May 2023. Please note that all maps/drawings should not exceed A3 in size.
