

Notice for Public Consultation on Appropriate Assessment

under Regulation 42 of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended

The EPA has given notice of its Appropriate Assessment Screening Determination to Donegal County Council for a facility located at Ballynacarrick, Ballintra, Donegal, F94 AY99 regarding an waste licence review application, Register Number W0024-05.

Classes and Nature of Activity in accordance with the Waste Management Act 1996 as amended

R04	No	Recycling/reclamation of metals and metal compounds
R05	No	Recycling/reclamation of other inorganic materials, which includes soil cleaning resulting in recovery of the soil and recycling of inorganic construction materials

Donegal County Council was granted a waste licence for the landfill facility at Ballynacarrick which closed in 2012. The licence review application is to change the boundary of the closed landfill to accommodate an Integrated Constructed Wetland (ICW) to provide a leachate management and

treatment system and include a proposed new emission point from the ICW to surface water.

The EPA has carried out an Appropriate Assessment Screening and has determined that an Appropriate Assessment <u>is required</u> for the activity. The applicant has submitted a Natura Impact Statement.

- Natura Impact Statement received from applicant
- Additional information submitted on the Natura Impact Statement

Information on making submissions or observations and on the public participation process is available on the Agency's website.

The EPA will consider any submissions received before making its decision. The EPA shall publish its proposed decision (grant/refusal) on its website, and before making a final decision, the EPA shall consider any objections / submissions on objections. The final decision will also be published on the website.
