## **AA Screening Determination:**

That the activity not directly connected with or necessary to the management of any European site and that it cannot be excluded, on the basis of objective information, that the activity individually or in combination with other plans or projects, will have a significant effect on any European site and accordingly determined that an Appropriate Assessment of the activity is required, and for this reason determined to require the applicant to submit a Natura Impact Statement.

This determination has been made in light of the following reasons:

• There is a hydrological connection between the installation and the Buckroney-Brittas Dunes and Fen SAC. Treated surface water/groundwater will discharge, via a wetland treatment system, to the River Potter. The River Potter flows into the Buckroney-Brittas Dunes and Fen SAC approximately 11.5 km downstream of emission point SW1. This discharge from the installation has the potential to have adverse effects on water quality in this European site with the potential effects on its water dependent qualifying interests.
