The Agency issued a notice on 10 November 2021 and a reminder notice on 3 June 2022 to advise Uisce Éireann that, in accordance with Regulation 14(5) of the European Union (Waste Water Discharge) Regulations 2007 to 2020, the Agency intends initiating a review of existing Waste Water Discharge Licence Register Number D0034-01 for the Ringsend agglomeration.

The Environmental Licensing Programme of the Office of Environmental Sustainability understands that at the meeting between the Agency and Uisce Éireann of 15 March 2023, Uisce Éireann indicated that it intended to submit a review application for Waste Water Discharge Licence Register Number D0034-01 in May/June 2023. It is noted that a review application has not yet been received.

Re: Notice for the purposes of Regulation 14(5) of the European Union (Waste Water Discharge) Regulations 2007 to 2020 – Review by the Agency of a Waste Water Discharge Licence

Dear Sir or Madam,

I am to advise, in accordance with Regulation 14(5) of the European Union (**Waste Water Discharge**) Regulations 2007 to 2020, that the Agency intends initiating a review of your existing Waste Water Discharge Licence, Register Number: D0034-01, for the Ringsend agglomeration.

The grounds for the review are set out in the [Regulation 14\(1\) Examination Report](#) which is available on the Agency website.

In accordance with the provisions of Regulation 14(7), you are required, for the purposes of the review of your licence, to submit via the 'review authorisation' function on the EDEN Online Portal the following:

- a) A completed application form and associated templates available on the EDEN portal and
- b) Fee as is appropriate having regard to the provisions of Regulation 39,

Your response to this request is to be submitted via EDEN within 6 months of the date of this notice. Guidance on how to make an application and completing the application form is available on the [EPA website](#).

In accordance with Regulation 14(3) the Agency shall publish a notice on its website stating that the EPA is initiating a review of your licence.

Submissions

In accordance with regulation 14(7)(b) submissions relating to the proposed review may be made in writing to the Agency at its headquarters within 5 weeks of receipt of the fee and completed application form, and the Agency shall not make a decision on the review before the expiry of the said period.

It should be noted that failure to comply with the above requirements is an offence. The EPA may proceed with its review in the absence of the information requested.
