Technical Amendment to Industrial Emissions Licence Register

Number: W0078-03, held by Tipperary County Council, for an installation

located at Ballaghveny Landfill, Ballymackey, County Tipperary.

The Agency received a request on 10 June 2022 from Tipperary County Council, Licence Reg. No. W0078-03 to technically amend its Licence. The request relates to a revision of the site boundary to remove three areas of land.

This memo recommends that the change may be accommodated by a Technical Amendment, in accordance with Section 96(1)(c) of Environmental Protection Agency Act 1992 as amended (hereafter referred to as the EPA Act).

1. Background

RE:

Tipperary County Council was granted a Licence, Reg. No. W0078-01, on 4 May 2001 to operate a waste licence located at Ballaghveny Landfill, Ballymackey, County Tipperary.

The licence has been revised twice, Reg. No. W0078-02 was issued to Tipperary County Council on 15 June 2006 and Reg No. W0078-03 issued on the 21 December 2009.

The installation is licenced under Classes 11.5 1 & 11.12 of the First Schedule to the EPA Act.

Licence Reg. No. W0078-03 has been amended on five occasions. The latest Technical Amendment, D (issued on 26 June 2020), amended wording Condition 6.2.2 (regarding leachate management). Two separate amendments requests were refused, a request for an alteration to Condition 6.2.2 (received prior to Technical Amendment D) and a request to increase the annual waste acceptance limitation in the existing licence.

The installation authorises Tipperary County Council to operate a non-hazardous landfill at a throughput of up to 49,000 tonnes per annum of municipal waste, commercial waste, construction and demolition waste, pre-treated sludge, and green waste for composting.

Waste acceptance at the installation ceased in February 2011 and resumed on the 2 April 2019 with approval of the Office of Environmental Enforcement (OEE).

2. Technical Amendment Request

On the 10 June 2022, the Agency received a request for a Technical Amendment of Licence Reg. No. W0078-03, to allow for a change in the licence boundary to reduce the licensed area of the installation.

The licensee proposes to remove three areas of land from the licensed boundary. This proposed reduction to the licenced area has been made as the licensee intends to sell the parcels of land and the licensable activity has never extended to the areas of land to be removed and there is no intent to operate on these areas of land. The licensee has submitted a map showing the areas of land to be removed (Appendix 1). The licensee has submitted a map showing the proposed new installation boundary (Appendix 2) for inclusion in the licence.

3. Consultation with the Office of Environmental Enforcement (OEE)

I have consulted with the OEE Inspector, Anthea Southey, in relation to this technical amendment request. The OEE confirmed that the proposed site boundary alteration cannot be accommodated under the existing licence. OEE have confirmed that an exit audit of the subject lands was carried out on the 23 September 2022 (Site Visit Ref. No. SV26014). The OEE has confirmed that there are no legal proceedings in train in respect of this licence.

4. Assessment

The proposed amendment request was assessed against the relevant criteria in the Agency's guidance for licence requirements³.

The licensee is proposing the removal of three areas of land situated along the northern boundary of the installation (as shown in Appendix 1). The licensee confirms that the land has not been used for the disposal or recovery of waste or for the operational processes of the landfill. There are no emissions to the land from the waste activities at the installation.

On the 23 September 2022, the OEE completed an exit audit at the site (Site Visit Ref. No. SV26014) for the purpose of inspecting the areas of land proposed for removal from the site boundary. The outcome of the exit audit was confirmation that the land was not subject to the licensable activities authorised by the EPA licence. The enforcement inspector determined that the land is not causing, or likely to cause, environmental pollution.

Section 96(1) of the EPA Act:

Section 96(1) of the EPA Act states that

"The Agency may amend a licence or revised licence for the purposes of -

- (a) correcting any clerical error therein,
- (b) facilitating the doing of anything pursuant to a condition attached to the licence where the doing of that thing may reasonably be regarded as having been contemplated by the terms of the condition or the terms of the licence taken as a whole but which was not expressly provided for in the condition, or

(c) otherwise facilitating the operation of the licence and the making of the amendment does not result in the relevant requirements of section 83(5) ceasing to be satisfied".

It is considered that the proposed amendment request may be accommodated under Section 96(1)(c). To amend the licence under this criterion, two parts need to be satisfied, Part (i) otherwise facilitating the operation of the licence and Part (ii) does not result in the relevant requirements of Section 83(5) ceasing to be satisfied. The change proposed, a decrease in the licensed area of the installation, is considered as otherwise facilitating the operation of the Licence. There are no emissions or activities associated with the lands requested to be removed and therefore the proposed change will not result in the relevant requirements of Section 83(5) ceasing to be satisfied.

Based on the above assessment, it is recommended that the changes to the licence to accommodate a reduction of the licensed boundary be accommodated by Technical Amendment. It is considered that the proposed revisions are in accordance with Agency guidelines for licence amendments³ and that the proposed alteration of the licensed site boundary (amended site boundary as shown in Appendix 2) will not have an impact on the emissions or environmental risk at the installation. The proposed amendment will satisfy the criteria under Section 96(1)(c) of the EPA Act allowing the Agency to amend a licence or revised licence.

The recommended amendment (RA) provides for the boundary decrease. The specific changes relate to the following condition of the licence:

Condition 1.4 – installation boundary.

5. Appropriate Assessment

Appendix 3 lists the European Sites assessed, their associated qualifying interests and conservation objectives.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Scohaboy (Sopwell) Bog SAC (Site code 002206), Kilduff, Devilsbit Mountain SAC (Site code 000934), Sharavogue Bog SAC (Site code 000585), Slievefelim to Silvermines Mountains SPA (Site code 004165), and Lough Derg, North-east Shore SAC (Site code 002241).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will not have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required. The reasons for this determination are:

- The installation is not located within any European site.
- The technical amendment relates to a reduction in the licensed boundary only. There
 are no changes to the nature or extent of the operations and emissions at the
 installation from what was considered during the assessment conducted for Licence
 Reg. No. W0078-03.

6. Recommendation

This memo recommends that the requested changes be accommodated by a Technical Amendment of Licence W0078-03 (held by Tipperary County Council), in accordance with Section 96(1)(c) of the EPA Act 1992 as amended.

I recommend that the licence amendment be approved as set out in the attached recommended Technical Amendment. The making of the amendment will not result in the relevant requirements of Section 83(5) of the EPA Act 1992 as amended, ceasing to be satisfied.




