

## **Notice for Public Consultation on Appropriate Assessment**

## under Regulation 42 of the European Communities (Birds and Natural Habitats) Regulations 2011 as amended

The EPA has given notice of its Appropriate Assessment Screening Determination to Uisce Éireann relating to an application for a review of Waste Water Discharge Licence for the Greater Dublin Area agglomeration, Co. Dublin, Register Number D0034-02. The waste water works serving the agglomeration is located in post codes Dublin 1 to Dublin 24 inclusive, as well as additional areas in County Dublin, County Kildare and County Meath.

This application is for the authorisation of waste water discharges from the waste water works serving the agglomeration. The application relates to waste water works, which includes an upgraded waste water treatment plant providing secondary treatment with Nitrogen and Phosphorous removal and UV disinfection during bathing season, and an existing Primary Discharge (SW001); 51 no. Dual Function Overflows (i.e., act as a Storm Water Overflow or Emergency Overflow depending on the event); 332 no. network Storm Water Overflows, 2 no. Emergency Overflows, associated sewer network and pumping stations The waste water discharges from the waste water works are to Liffey Estuary Lower (IE\_EA\_090\_0300) and to receiving waterbodies as per the table below. The population equivalent (p.e) to which the application relates is 2,400,000 p.e.

Information on making submissions or observations and on the public participation process is available on the Agency's website.

The EPA shall publish its decision (grant/refusal) on its website, and before making a decision, the EPA shall consider any submissions.
