The EPA has received an application review from the above referenced applicant Starrus Eco Holdings Limited.

The applicant proposes, as part of this application, to provide for the discharge of process effluent to your sewer. Process effluent includes trade effluent or other matter (other than domestic sewage or storm water). Details of the proposed emissions to the sewer are contained in the "Emissions – Sewer Section" Template of the Online Application which can be viewed at www.epa.ie.

I would appreciate if you could confirm whether or not an Order under Section 22 of the Local Government (Water Pollution) (Amendment) Act, 1990, was made and confirmed by Uisce Éireann, in respect of this sewer, and if so, could you please furnish the EPA with a copy of same.

I am to request your consent to the proposed discharge under Section 99E of the EPA Act as amended. I should also add that in accordance with the legislation, your consent may be subject to such conditions as Uisce Éireann considers appropriate. For your convenience please find attached a reply form including a list of draft conditions compiled by the EPA.

An oil separator on the storm water discharge from yard areas.

- a. The silt traps and separator shall be in accordance with I.S. EN-858-2: 2003 (separator systems for light liquids).
- 5. No specified emission from the installation shall exceed the emission limit values set out in *Schedule B: Emission Limits*, of this licence. There shall be no other emissions of environmental significance.
- 6. Other than the trade effluent authorised to be discharged under this licence, the licensee shall at no time discharge or cause or permit to discharge into sewer trade effluent or any other matter unless authorised in writing by Uisce Éireann.
- 7 The licensee shall carry out such sampling, analyses, measurements, examinations, maintenance and calibrations as set out below and as in accordance with *Schedule C: Control & Monitoring*, of this licence.
 - Sampling and analysis shall be undertaken by competent staff in accordance with documented operating procedures.
 - Such procedures shall be subject to a programme of Analytical Quality Control using appropriate control standards with evaluation of test responses.
 - Where any analysis is sub-contracted it shall be outsourced to a competent laboratory.
- 8. Monitoring and analysis equipment shall be installed, operated and maintained as necessary, so that all monitoring accurately reflects the emission/discharge.
