Please see below further information clarifying the details in the wastewater discharge licence review application (D0423-02) on the proposed stormwater overflow (SWO) at the Whitegate-Aghada WwTP; There will be a proposed Stormwater Overflow from the new Stormwater Holding Tank located at the WwTP. Upon commissioning of the new WwTP, flow monitoring will be in place to measure any spills from this SWO and will be connected to the WwTP Scada system. Further details on this SWO are below;
