Attachment-6-3-7-Project and Thresholds for Planning

Planning permission was required for the data storage facilities at the Installation. The planning history of the site is set out in Attachment 6.1 Stakeholder-Engagement. The installation has received Final Grant of planning permission from Dublin County Council (DCC) under the separate applications listed below:

- Building W; final grant of permission on 2 April 2012 (DCC Reg. Ref.: 3534/11).
- Building X and Y; final grant of permission on 19 August 2013 (DCC Reg. Ref.: 2688/13), and final grant of permission on 24 October 2013 DCC Reg. Ref.: 2979/13)
- Building U and V: final grant of permission on 05 July 2019 DCC Reg Ref.: 2229/19, and 18 November 2020 DCC Reg. Ref.:18 November 2020, and on 24 August 2022 DCC Reg. Ref. 3641/21.

All planning permissions for the data storage facilities that are relevant to this Licence review application under Class 2.1 of the EPA Act 1992 (as amended) have been granted. All relevant information relating to the environmental assessment of the activity is made available and contained within Section 7 of this licence application.

Schedule 5 Activities

Appropriate Assessment (AA) Screening assessments have been prepared as part of this IE Licence Review application for Buildings W, X and Y (included as Attachment-6-3-4-AA Screening Licence-Apr-2022), and for Buildings U and V (included as Attachment-6-3-4-AA Screening Planning-Aug 2022).
