**Application to the Environmental Protection Agency for A Licence.**

Notice is hereby given in accordance with the E.P.A. Acts 1992 to 2013 that Enfield Broiler Breeders Limited, Unit B, Maynooth Business Campus, Straffan Road, Maynooth, Kildare intend to apply to the Environmental Protection Agency (E.P.A.) for an Industrial Emissions Licence for their poultry farm at Gortean, Broadford, Co. Limerick. National Grid Reference E530342, N624720.

This enterprise is classed as: Activity Class 6.1 (a) 'The rearing of poultry in installations where the capacity exceeds 40,000 places.' An Environmental Impact Assessment Report relating to this activity, which has previously been submitted to Limerick County Council, will be submitted to the Agency as part of this application. The environmental impact assessment report submitted to the Agency in accordance with section 83(2A)(d) of the Act of 1992, any information provided to the Agency under paragraph (e) or (f)(ii) (ii) of section 83(2A) of the Act of 1992, any opinion issued by the Agency under section 83(2A)(de) of the Act of 1992 on the scope of the environmental impact assessment report, and any further information, including reports and advice, relating to the environmental impact assessment as may be furnished to the Agency in the course of the Agency's consideration of the application, shall each be made available on the Agency's website and at the headquarters of the Agency.

Submissions may be made in writing to the Agency in relation to the likely effects on the environment of the proposed activity within the period specified by the Agency on its website under Regulation 4(2)(c). In accordance with section 87(2) of the Act of 1992, a proposed determination shall be published by the Agency on its website. A copy of the application for the licence may be inspected on the Agency's website or inspected at or obtained from the headquarters of the Agency as soon as is practicable after the receipt by the Agency of the application for the licence.
