#### Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0304-01 granted on 15 October 2020 and amended on 10 June 2022, as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of section 40(4) of the Waste Management Act 1996 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Bray Head SAC (000714), Ballyman Glen SAC (000713), Knocksink Wood SAC (000725) Glen of the Downs SAC (000719), Wicklow Mountains SAC (002122), Rockabill to Dalkey Island SAC (003000), Carriggower Bog SAC (000716), The Murrough Wetlands SAC (002249), South Dublin Bay SAC (000210), Wicklow Mountains SPA (004040), Dalkey Islands SPA (004172), The Murrough SPA (004186), South Dublin Bay and River Tolka Estuary SPA (004024).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required.

This determination is based on the following reasons:

- The installation is not within any European Site;
- The amendment is limited to a change to facility boundary only. There are no changes to the nature or extent of the operations and emissions at the facility from what was considered during the assessment conducted for licence registration no. W0304-01. Therefore, there will be no impact on any European Site as a result of the amendment request.

#### Technical Amendment

In pursuance of the powers conferred on it by section 42B(1)(C) of the Waste Management Act 1996 as amended, the Agency amends the licence, granted to Packaging Laundry Limited, for a facility located at Unit C4, Oldcourt Industrial Estate, Boghall Road, Bray, County Wicklow.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 10 June 2022, and the amendments set out below.

This Technical Amendment is limited to the following Conditions:

### **Amendments**

#### **Amended Conditions**

Amend Condition 1.3, of the existing licence to read as follows:

1.3 For the purposes of this licence, the facility authorised by this licence is the area of land outlined in red on Drawing No. 'Figure No. 2 (v5) – Proposed Site Layout with Increased Boundary', dated July 2024. Any reference in this licence to "facility" shall mean the area thus outlined in red. The licensed activities shall be carried on only within the area outlined.

Append the following to Condition 3, of the existing licence:

3.17 The operations undertaken in the area shaded in green on Drawing No. 'Figure No. 2 (v5) – Proposed Site Layout with Increased Boundary', dated July 2024, is limited to the storage of clean, uncontaminated Integrated Bulk Containers (IBC's) only.

This Technical Amendment shall be cited as Amendment B to the licence.
