## *Reasons for the Decision*

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0254-01 granted on 23 October 2013 and amended on 27 May 2020 and 07 December 2023 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of section 40(4) of the Waste Management Act 1996 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects are likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Red Bog SAC (000397), Poulaphouca Reservoir SPA (004063), Wicklow Mountains SAC (002122), Wicklow Mountains SPA (004040), Mouds Bog SAC (002331), Pollardstown Fen SAC (000396), Ballynafagh Lake SAC (001387), and Ballynafagh Bog SAC (000391).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required.

This determination is based on the following reasons:

- The facility is not located within a European Site.
- There is no hydrogeological connection between the facility and these European Sites.
- There will be no emissions of environmental significance from the activity. Therefore, there will be no impact on any European Site as a result of the amendment request.

## *Technical Amendment*

In pursuance of the powers conferred on it by section 42B(1)(c) of the Waste Management Act 1996 as amended, the Agency amends the licence, granted to Walshestown Restoration Limited, for a facility located at Walshestown, Blackhall, Tipperkevin and Bawnoge, Naas, County Kildare.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 27 May 2020 and Amendment B issued on the 07 December 2023 and the amendments set out below.

This Technical Amendment is limited to the following Schedule:
