Our client (Bord na Móna) are currently in the process of updating the IPC license boundary for the bog surrounding the proposed Drehid project to account for the proposed development at the site (as we had previously discussed). Please see attached correspondence they have sent to the EPA inspector (Billy Shanahan) for the IPC license change.

We would greatly appreciate it if you could make contact with Billy internally to see if there is any way to streamline the two applications, with a view to improving the overall timeline for the project. As you are probably aware, it is considered crucial that the IE license application is decided upon as soon as possible in order to avoid significant waste management and waste disposal capacity deficit in Ireland as the existing Drehid landfill is fast approaching its maximum disposal capacity.
