Act 1992 as amended, that Mr. Paul Tully, Moate Pig Unit, Ballinakill, Portlaoise, Laois intends to apply to the Environmental Protection Agency (E.P.A.) for the review of the industrial emissions licence for the installation at Moate Pig Unit, Ballinakill, Portlaoise, Laois, National Grid Reference E248380, N183133. This enterprise is classed as: Activity Class 6.2: 'The rearing of pigs in an installation where the capacity exceeds - (b) 2,000 places for production pigs which are each over 30kg'. An Environmental Impact Assessment Report relating to this activity, which has been submitted to Laois Planning Authority (Planning Register Reference Number:

2460311), will be submitted to the Agency as part of this application. The environmental impact assessment report submitted to the Agency in accordance with section 83(2A)(d) of the Act of 1992, any information provided to the Agency under paragraph (e) or (f)(ii)(I) of section 83(2A) of the Act of 1992, any opinion issued by the Agency under section 83(2A)(de) of the Act of 1992 on the scope of the environmental impact assessment report, and any further information, including reports and advice, relating to the environmental impact assessment as may be furnished to the Agency in the course of the Agency's consideration of the application, shall each be made available on the Agency's website and at the headquarters of the Agency. Submissions may be made in writing to the Agency in relation to the likely effects on the environment of the proposed activity within the period specified by the Agency on its website under Regulation 4(2)(c). In accordance with section 87(2) of the Act of 1992, a proposed determination shall be published by the Agency on its website. A copy of the application for the licence may be inspected on the Agency's website or inspected at or obtained from the headquarters of the Agency as soon as is practicable after the receipt by the Agency of the application for the licence.
